A total of \$ _____ plus 6.5% sales tax is expected to be received by Love a Lot Cavaliers before the puppy will be given to said owner. Purchase may be made with a check, cash or money order. If any checks written for the purchase or transportation of the pup does not clear the bank, seller has the right to take the puppy back from the purchaser with no refund on any money already given to Love A Lot Cavaliers. A \$30.00 charge for each bounced check will be enforced. An agreed upon deposit must be given to Love a Lot Cavaliers to reserve a puppy. Reservations will be made on a first come first serve basis. Once a deposit is placed on a particular puppy already born, it can not be transferred to another pup at a later date unless that puppy dies under the care of the breeder. If a deposit is placed on an unborn puppy, first deposit held gets first pick, second deposit gets second pick and so on. Buyer has the option to adopt the previously discussed pick (color/sex) upon birth or transfer the deposit to the next available litter, but the decision must be made upon birth of the puppies. In the event the buyer is unable to purchase the puppy for any reason regardless of whether it has been placed on a puppy already born or an unborn puppy, 100% of the deposit money or any other money already given towards the balance will be kept by the seller. In the event that two pups will be purchased at the same time, a separate deposit is required for each pup. In the event that the buyer decides to cancel purchase of either pup, the deposit can not be transferred or applied to the other puppy already chosen by the buyer. In the event the buyer decides to return the puppy after it has been taken home, Love A Lot Cavaliers will still retain any money received for that puppy unless it falls under the genetic issue guarantee listed below. The puppy will retain the name LoveALot on the Official AKC registration papers before the name given by the new owner. For example, LoveALot Benji. If the puppy is purchased on a limited breeding contract, the AKC registration papers will not be given to the buyer until the puppy has been spayed/neutered or until any remaining balance has been paid. A report from the vet will be required to receive AKC papers.

- Buyer will receive AKC papers when remaining balance is paid.
- Buyer will receive AKC papers when picking up/shipping puppy.
- Buyer will receive AKC papers upon required documents from Vet regarding spay/neuter contract.
- Buyer will not receive AKC papers.

Every puppy is healthy upon shipment/pick up to the best of my knowledge. Therefore, the buyer must take the puppy to the Vet for a full examination within 72 hours upon receipt, otherwise the health contract is null and void. Puppy will be guaranteed for one year from the date of birth for these congenital defects (hip/eye disorders and MVD (Mitro Valve Disease). If any puppy is found to have one of these **genetic** disorders, the buyer must produce a written and signed statement from the vet explaining the disorder. Upon receiving the vet notification, the buyer may choose to replace the puppy by returning the current puppy at the buyer's expense. The puppy will be replaced from the next available litter whelped from a different parent. Under the unlikely event that a puppy dies, an autopsy must be completed at the buyer's expense showing the cause of death before receiving a new puppy. Any other condition such as parvo, distemper, seizures, temperament etc. will not be covered under the guarantee. Medical expenses, travel expense, surgeries etc. will not be reimbursed from the seller for any reason.
